Meeting with San Diego employees regarding proposed FY 2023 Budget

Objective: To discuss with the City analyst each of the 5 proposed budgets for FY 2023 and to approve or not approve

Process: The budgets were presented, and questions answered individually and voted on.

Many questions answered at the first presentation (Kensington Heights), helped the process along because if presented they were redundant. Questions were asked about what constituted CIP.

Motion to approve Kensington Heights budget as presented, with an increase in the assessment to \$101.26 made by Deborah Sharpe, second by Carolyn Satter, approved 3-0.

Motion to approve Kensington Manor budget as presented, with an increase in the assessment to \$100.11 made by Carolyn Satter, second by Priscilla Berge, approved 3-0.

Motion to approve Kensington Park North budget as presented with an increase in the assessment to \$104.59 made by Carolyn Satter, second by Gary Rosoff, approved 2-0.

Motion to approve Talmadge Park North budget as presented with an increase in the assessment to \$90.27 was made by Carolyn Satter. The motion failed for lack of a second.

There is ongoing frustration with street lights on the Talmadge Park North loop being out for extended periods. At one point they were returned to service, and after 7 weeks they were out again. When a Get It Done order was placed, it was said that the items were fixed, which they were not. Streets affected are Argos Drive-1 block, East Alder, West Alder and Alder Drive.

There will be a revisit of this proposed budget when the streetlights are operational.

Motion to approved the Talmadge Park South budget as presented with an increase in the assessment to \$85.55 made by Carolyn Satter, second by Marc McKnight, approved 2-0.

The time line for planning group approval is January 2022.

Concluding:

Anymore issues to be reported to both Loren Boerboom and Elvis Martinez directly while also submitting a Get It Done request.

Once the lights Talmadge North are restored, communication with the City will be to set up a Zoom meeting for FY 2023 approval.
