The meeting was called to order and the Kensington Heights MAD budget for FY 2024 was presented, with an explanation of each line item. This was followed by a question and answer period.

**ACTION** – **KENSINGTON HEIGHTS** - Recommend to the full KTPG on the City's proposed KMAD budget for the FY 2023m as well as possible cost of living increases to the FY 2024 assessments of the Kensington Maintenance Assessment District. While the budget was reviewed, a quorum was not present. Ken Baer requested information on where the funds are coming for the Circuit#2 upgrade and the specific cost of the planned replacement lamp posts

**ACTION – KENSINGTON MANOR** - Recommend to the full KTPG on the City's proposed KMAD budget for the FY 2023m as well as possible cost of living increases to the FY 2024 assessments of the Kensington Maintenance Assessment District. There was a request for rewording the statement that appears on the proposed budget "UNALLOCATED Reserve (Available for Future CIP by striking the reference to Available for Future CIP.

**ACTION – KENSINGTON PARK NORTH** - Recommend to the full KTPG on the City's proposed KMAD budget for the FY 2023m as well as possible cost of living increases to the FY 2024 assessments of the Kensington Maintenance Assessment District. Gary Rosoff made the motion with Carolyn Satter seconding. **Motion passed unanimously** 

**ACTION – TALMADGE PARK NORTH** - - Recommend to the full KTPG on the City's proposed KMAD budget for the FY 2023m as well as possible cost of living increases to the FY 2024 assessments of the Kensington Maintenance Assessment District. No motion of approval was made. Boardmembers wanted the answers to the following questions before voting. (1) When will the City evaluate the Circuitry and begin the street light upgrade (2) When is the underground project happening?

**ACTION – TALMADGE PARK SOUTH-** While the budget was present, no quorum was present. A follow-up meeting was set for Tuesday, December at 6:30pm to present the 4 proposed budgets that were not approved. Responses to the items of concern will be presented and a vote will be called for.
