Motion:

The Kensington Heights MAD does not approve the FY 2024 Kensington Heights proposed budget based on the following:

- the budget does not provide transparency for all future construction plans;
- line item 512132 does not include the portion of the cost of the Circuit #2 Upgrade to be appropriated from the Kensington Heights MAD;
- the budget does not include inspection of the 56 poles/luminaires involved in the upgrade to determine which can be restored, as requested; and
- the that restoration/replacement should be modeled upon the Empire style poles and fixtures installed at 4126 Middlesex Drive.

The Kensington Heights MAD proposes that up to \$10,000 of Kensington Heights MAD funds be allocated to hire a company to inspect each of the 56 poles/luminaires cited in the Circuit #2 Upgrade and estimate the cost to restore each pole, in lieu of removal and replacement, as proposed by the City.
