You will be required to provide 1) a valid government issued ID with a current Kensington-Talmadge address, or 2) in the case where the government issued ID does not contain a Kensington-Talmadge address, you must provide a current original utility or property tax bill, or an item of first class mail addressed to the voter that is no more than 30 days old.*
