II <u>Community Forum/Non-Agenda Public Comment</u> (6:40 – 20 min)

Action Item: Establish new meeting location and procedures.

The governor's executive order, which suspended certain provisions of the Ralph M. Brown Act concerning public access to meetings, will lapse on September 30th. Regular meeting procedures that fully comply with the Brown Act must resume after that date.

A. <u>CIP & Planning</u> Chair: David Moty

Information Item: Preliminary review of the City's "Homes for All of Us" proposal. Key aspects are: additional incentives for affordable housing and single room occupancy hotels in Transit Priority Areas; density, FAR, setback, and lot coverage incentives for ADA housing; establishment of an Employee Housing Incentive Program; allowing non-profits to build affordable housing anywhere within high/highest resource census tracts under certain conditions (see: https://belonging.berkeley.edu/2021-tcac-opportunity-map); flexibility in live/work construction; and new rules on construction timing for inclusionary housing. Additionally, removes storage uses from the CU zones found on El Cajon Boulevard.
